Dear Mr. Donald Trump!

On February 2, 2018, the work of the Higher Power of the Union of Soviet Socialist Republics in the person of the Supreme Council - the Government of the USSR was resumed, and I have the honor to notify you and in your person - the Great American People.

On the basis of the Charter of the United Nations, international law and the Constitution of the USSR, the real status of the Soviet people as the founder of their Great Country and the winner of fascism in the Second World War (together with your Great People) was restored.

Millions of our compatriots remained on the battlefields of the Second World War, we remember about this and bear responsibility for it.

Time management territory of the USSR Gorbachev false firms - Yeltsin -Putina - Medvedev discontinued, constitutional order was restored.

We ask you to follow the necessary diplomatic steps to open a proper US diplomatic representation in the USSR; to prevent the representation of "interests of the USSR" in the United States by individuals and organizations that do not have the authority of the USSR state in your country (Azerbaijan, Armenia, Belarus, Georgia, Kazakhstan, Kyrgyzstan, Latvia, Lithuania, Moldova, Russian Federation, Tajikistan, Turkmenistan, Ukraine, Estonia).

The Soviet Union restores its rights, property, territory, being freed from "false successors" and "pseudo-proxies".

We are showing a peaceful attitude towards all states and peoples of the world, leaving behind our complete sovereignty and inviolability of state borders.

The territorial space of the USSR is sufficient for the development of the entire multinational people, the USSR does not need expansion to foreign territories. The Soviet Union

is a peaceful, socially-oriented state in its development, which is notified to the entire world community.

Under the illegal cover of the international institutions of the United Nations, we believe that during the period from 1991 to the present, a number of serious crimes have been committed against citizens of the USSR and the Soviet state in order to deceive our people, deprive them of their human rights, property, territory and life itself . We have identified "tools" for the implementation of this special operation and are able to recognize its causes, performers with the necessary diplomatic and non-diplomatic conclusions and decisions, subject to further implementation.

Private companies - the "RF" and others, including those registered in the US jurisdiction, are consistently and steadily being expelled from the territory of the USSR, their initiators, leaders and others - are awaiting the initiation of criminal prosecution under the laws of the USSR.

Criminals and corrupt officials brought public property to Western countries and the United States of America. We ask you and your Government, the American people - to render all possible assistance in returning the property of the USSR, in identifying illegally withdrawn assets and liabilities of the Soviet people and the Soviet state, are ready to accept with gratitude the assistance of your state in this respect.

At the same time, we are concerned about the opposition of the pro-Putin criminal regime on the territory of the RSFSR and the US, as well as escalating the military presence and confrontation of NATO along and within the borders of the USSR.

The government of the USSR - the Supreme Soviet of the USSR does not intend to unleash a war against any states, pursue an aggressive policy against any peoples with a further increase in the number of weapons of mass destruction. At the same time, the world situation has developed in the third world war, and practically all countries of the world are already involved in it.

NATO alliance with the help of local mercenaries organized the intervention of its military forces in the territories of the USSR. NATO mercenaries are already present in Ukraine, in Georgia and in the territories of other republics, deployed numerous military bases throughout Europe and even in the territory of the RSFSR. The troops of NATO's hired forces are concentrated along the borders of the RSFSR, in the east of the RSFSR the US military fleet is being pulled down. All this indicates the preparation of direct military intervention by NATO and US forces in the territory of the RSFSR / USSR.

We hope that the American people are ready to stand up for the establishment and protection of peace, to stop further killings of the peoples of the world in military conflicts.

The Soviet people has never in the past unleashed a single war and does not intend to continue to take part in wars against any nations or countries. At the same time, we will not allow anyone else to invade our territory.

Understanding the responsibility of our states for the fate of the world, we appeal to you with a convincing request - to withdraw troops from the borders of the USSR, to withdraw bases from the territory of the USSR and the territory of Europe. Remove all mercenary NATO units from the territory of the USSR (the Ukrainian Soviet Union, the Georgian Soviet Union, the Kazakh SSR, etc.), withdraw the US military fleet from the Soviet coasts in the east of our country.

Dear Mr. Donald Trump, we expect due attention to this letter. In the absence of an official response, we will have to consider the build-up of NATO troops at the borders of the USSR - a policy of collusion between the administration of the US Government and the private American company "Russian Federation" ("Russia", etc.) - Putin-Medvedev, for the purpose of intervening and seizure of the territory of the USSR, as evidenced by repeated meetings and talks between Putin and Trump and law enforcement agencies on both sides.

Once again, we express our commitment to the course of peace and mutual assistance, mutual understanding, the solution of all bilateral and multilateral issues of world politics without the manifestation of aggression and military coercion.
